Feature of our Will – Testamentary Trusts

Clients of Papson Legal have the advantage of having a will that features testamentary trusts. Although we will evaluate each client individually, there are some general features of having a will with testamentary trusts. These are as follows.

- Asset Protection. The assets passed to your beneficiaries will be held in trust, and therefore protecting these assets from creditors of your beneficiaries, as well as the beneficiaries themselves (for example, if your beneficiaries were dependent on illicit drugs). We can also tailor the trusts such that the capital is protected.
- Tax Advantages. If you have children under the age of 18, there are tax advantages associated with streaming income to those beneficiaries.
- Ability to stream income. The testamentary trust is similar to a 'discretionary' or 'family' trust in nature. Therefore, there is the opportunity for income to be streamed to a number of beneficiaries.

Aside from the above general advantages, Papson Legal's testamentary trusts contain relevant provisions for the trusts to be administered with ease.
